As a member of the Boys & Girls Club of Laguna Beach, I have read and understood all of the following guidelines regarding the use of computers/WiFi while at the Club.

- I will never access the Internet without permission from a Boys & Girls Club staff member.
- I will use the Internet for educational purposes which are limited to school-related assignments and activities supervised by Club staff.
- I will treat all Club equipment with care and respect *(computers, printers, iPads, software, cameras, video equipment, etc.)*
- I will never use the Internet or the Boys & Girls Club Network to access inappropriate material, including but not limited to language, images and subject matter.
- If I bring my own device *(personal/school-issued Chromebook/tablet/computer)*, I will only use it for homework and academic-based projects.
- Technology games may be used at the discretion of Club Staff.

By signing this contract, I agree to follow all rules while using computers and other technology at the Boys & Girls Club. **I understand that if I choose to break any of these rules, I will no longer be allowed to access the Club's technology equipment/WiFi.** I know that I am responsible for my own actions, and if I do not follow all of these rules while using Club equipment, I understand there will be consequences.
